Philosophy, Politics, and Economics 2022 Admissions Round Feedback

Please note this is subject admissions feedback from the 2022 selection round - there will be changes each year, and these pages are only retained to provide a general indication of process.

The PPE admissions tutors would like to thank all applicants for the time and care they put into their applications. We are also grateful to referees for proving their supporting statements and for the encouragement and support they give to applicants.

The University received 1849 applications for PPE this year, of whom around 39% were shortlisted for interview. Offers were made to 265 applicants, nine of which were for deferred entry. There were 46 first choice applications to Keble, including one for 2024 entry; 16 of these were shortlisted and another five allocated from other colleges. Eight offers were made for 2023. With such high numbers of applicants it is not feasible to invite everyone for admissions interviews and only those with a realistic chance of being made an offer are interviewed. The decision to shortlist was based on: UCAS information about past and predicted exam results; UCAS academic reference; and the result of the Thinking Skills Assessment test (TSA Oxford). For UK-based candidates, we are typically aware of achievement that goes above or below the norm for the school as measured by contextualized data, and this year we paid even close attention to the possible and uneven impacts of the disruption to teaching and assessment caused by the Covid-19 pandemic. The Thinking Skills Assessment is a two-hour test involving multiple-choice reasoning questions and an essay. Each candidate should be issued a statement of results by ATS (the TSA provider) on January 11th. They can be accessed via Cambridge Assessment's <u>Results Online</u> system. The average test performance of applicants at the different stages is set out in the summary report on the PPE course website.

Candidates who score well in the TSA, above an agreed threshold and had good exam results and references were likely to be asked for interview. Candidates scoring below a lower threshold will only have been invited for interview with special consideration of other factors. Candidates who scored between the upper and lower thresholds may have been invited for interview.

In their assessment of individual applications, the tutors took account of contextual data concerning relative individual and school performance as well as some background characteristics related to place of residence. This information is available only for applicants from within the UK. Applications to colleges for PPE vary every year and colleges have varying numbers of places to offer. Where a college has a large number of shortlisted candidates relative to its places there is a process by which candidates are reallocated to colleges with lower shortlisted candidate to place ratios. This process, which is operated centrally, is designed to minimise the effect of college choice on an applicant's chances of being made an offer. Candidates selected for reallocation are those for whom information available at the shortlisting stage suggests the chance of acceptance can be improved by reallocation.

PPE tutors are looking for evidence of the following qualities in applicants:

- Application and interest: capacity for sustained study, motivation and interest, an independent and reflective approach to learning;
- Reasoning ability: ability to analyse and solve problems using logical and critical approaches, ability to assess relevance, capacity to construct and critically assess arguments, flexibility and willingness to consider alternative views;
- Communication: willingness and ability to express ideas clearly and effectively on paper and orally; ability to listen; ability to give considered responses.

Throughout the admissions process, tutors seek to detect the candidate's future potential as a PPE student. Existing achievement (as revealed in official examinations, predicted examination results, and school reports), as well as performance in the pre-interview TSA admissions test and interview, is relied upon mainly as evidence of future potential.

At Keble, each shortlisted applicant was given three independent interviews by subject tutors in Philosophy (20 minutes), Politics (15 minutes), and Economics (15 minutes). Interviews were conducted online via Teams. The Philosophy interviews consisted of two main questions, with discussion of each taking up about half of the interview. Each question was designed to test applicants' critical and analytical thinking skills. Neither required any previous experience in philosophy or specific background knowledge. There was no advance reading. Politics interviews also featured two questions which did not assume any background knowledge in the subject. In Economics, applicants were asked to consider problems.

Final decisions about offers of places used the full range of evidence available, including past and predicted exam results, the school report, the personal statement, the TSA admissions test and the interviews. Give that there are only eight places available a year for PPE in Keble, it was not possible to make an offer to every applicant whose potential might otherwise merit a place at the University.
